#### PRESENTATION FROM MAYOR HEARNS

# CA 1. PLANNING COMMISSION APPOINTMENTS/ APPOINTMENT PROCEDURES AND TERMS

The Deputy City Attorney briefly stated that there is a certain methodology and preparation for the appointment process of planning commissioners. She stated that she does concur with the opinion of the Attorney General of the State of California regarding the appointment of Planning Commissioners. While many General Law cities with elected mayors have historically used other methods to select their Planning Commissioners, the 2006 opinion of the Attorney General makes clear that Planning Commissioners should be appointed by the elected Mayor, subject to ratification by the full City Council. Regardless of the criteria used by the mayor to select new Planning Commissioners for approval by the full City Council, it will be important to revise the City's Municipal Code to reflect the appointment methodology described in the opinion.

Mayor Parris stated that past practices are no longer valid, agrees with the decision by the Attorney General. He would like to see an application process and encouraged citizens who reside in Lancaster to apply for the positions with a deadline of May 6, 2008 to submit applications to the City Clerk. The term of the commissioners would be for two years.

Vice Mayor Smith suggested that the current appointment of Planning Commissioners be continued for 30 days and to direct staff to come back with a clear ordinance.

Council Member Sileo requested clarification regarding the Attorney General opinion and validity of past decisions made by the current Planning Commission.

The Deputy City Attorney stated that decisions by the Planning Commissioners are valid, as the appointment of those commissioners was by approval of the entire City Council.

### CA 1. (continued)

Addressing the City Council on this matter:

Greg Morgan – in favor of the proposal, feels that it is a good idea.

James Shanbron – in favor of the proposal; excellent example of transparency in government; encourages the public to become more involved.

Sandy Smith – in favor of the proposal; there are many qualified citizens that would like to be involved.

Diana Beard-Williams – in favor of the proposal.

Gene Gaynor – in favor of the proposal – supports the concept.

Jeff Moffatt – in favor of the proposal; new commission will be essential to the process. Jeannette Buteyn – in favor of the proposal; gives a fresh positive start.

Bruce MacPherson – congratulated Mayor Parris and Council Member Marquez for being elected. He appreciates the approach; there is no arguing with state law; his position is at the will of the City Council and he will abide faithfully.

Darren Parker – in favor of the proposal; a new beginning; City has taken baby steps and it is now time to take adult steps.

Richard Hecker – stated that Council must follow state law; process needs to be adjusted; the current Planning Commission has done a great job.

At the request of Council Member Elect Mann, Mayor Parris read a letter from Mr. Mann that stated that since he was unable to attend the meeting, he would like Council Agenda Item Nos. CA 1; CA 2 and CA 3 continued until he can be present to participate in the discussion.

On a motion by Vice Mayor Smith and seconded by Mayor Parris, the City Council approved an application process, continue making appointments for thirty days, set the deadline for May 6, 2008 to submit applications to the City Clerk; directed staff to come back with a clear ordinance and encouraged citizens who reside in Lancaster to apply for the two-year term positions, by the following vote: 4-0-0-0; AYES: Marquez; Sileo, Smith, Parris; NOES: None; ABSTAIN: None; ABSENT: None.

### CA 2. REMOVAL OF PLANNING COMMISSIONERS

Reflective of the discussion pertaining to CA 1, Mayor Parris requested that Commissioners Faux and MacPherson step down from their appointments as Planning Commissioners and encouraged them to re-apply through the new process.

Council Member Sileo appealed to the former commissioners that are now on the City Council, stating that it takes time to get up to speed on projects and that it is important to plan for the goals the City has set forth. He had concerns regarding the General Plan; Specific Plan and felt that it was not necessary to remove the current commissioners – they are experienced and should remain on the commission.

Mayor Parris agreed with the reasoning of Council Member Sileo, stating that he has no argument with that. He will consider all applications and encouraged the current commissioners to re-apply if they so desire, then Council can accept or reject. It is time for the Planning Commission and the City Council to work together; encouraged everyone to get an application; time to remove the toxicity from the office to excel and accomplish wonderful things for this City.

On a motion by Mayor Parris and seconded by Vice Mayor Smith, the City Council approved the removal of the commissioners from the Planning Commission by the following vote: 3-1-0-0; AYES: Marquez, Smith, Parris; NOES: Sileo; ABSTAIN: None; ABSENT: None.

### CA 3. CREATION OF A MAYOR EMERITUS ROLE

Mayor Parris stated that there are many demands from different avenues of the City where it is important that Lancaster is well represented, particularly during ceremonial events. He stated that he would like to have Mayors Roberts and Hearns selected as Mayor Emeriti/Honorary Mayors for a term of two years, to assist Lancaster with some of these events, in the event that the Mayor, Vice Mayor or the Council could not attend.

Vice Mayor Smith stated that Mayor Roberts and Mayor Hearns would be wonderful representatives for Lancaster; no one can fill their shoes and the City will be well represented.

Council Member Sileo requested clarification from the Deputy City Attorney on any policy that is in place.

The Deputy City Attorney stated that the duties are stated in the Municipal Code; set forth by the order of the City Council and since these positions would be honorary and with no authority behind them, it meets the specifications in the Code.

Addressing the City Council on this matter:

Former Mayor, Henry Hearns – Stated that he looks forward to the commitment and will support the current Mayor; he will be happy to do this.

Former Mayor, Frank Roberts – Stated that Lancaster is a great City; he feels that people will appreciate this kind of service; he will commit and support this appointment.

On a motion by Mayor Parris and seconded by Vice Mayor Smith, the City Council approved the two-year appointments of former Mayor Roberts and former Mayor Hearns as Mayor Emeriti/Honorary Mayors, by the following vote: 4-0-0-0; AYES: Marquez; Sileo, Smith, Parris; NOES: None; ABSTAIN: None; ABSENT: None.

#### ANNOUNCEMENT FROM THE MAYOR

Mayor Parris introduced Jon Sisson, Jason Shuler and Noah Lomax from Lancaster Baptist. He stated that these three young men worked diligently on his campaign and that he was proud to state that they are his only power brokers and thanked them for all of their hard work.

### INTERIM CITY MANAGER/INTERIM EXECUTIVE DIRECTOR ANNOUNCEMENTS

The Interim City Manager, Mark Bozigian, thanked several staff members for their hard work and diligence in preparation of the reception and pulling the City Council meeting together. Additionally, he thanked Deputy City Attorneys Joe Adams and Allison Burns for taking on all the demands of the City.

The Parks, Recreation and Arts Director gave a brief presentation regarding the 17<sup>th</sup> Annual Poppy Festival, stating that staff did a great job; 41,000 attendance; overcame the weather; introduced Laurie Butts, the Special Events Manager; this was a collective event and she made sure everything was taken care of.

Cleo Goss – congratulated Mayor Parris and Council Member Marquez; likes idea of the walk with the Mayor; encouraged him to walk at the location of 60<sup>th</sup> Street West and Avenue L during school days; problems regarding development at this site; criminal element that will be attracted to this area; changing the zone will bring in crime.

Gary Burgess – congratulated Mayor Parris and Council Member Marquez; thanked Mayor Hearns; Vice Mayor Visokey and Council Member Jeffra for their relationship in improving the community; entire Council shows that they care; great City staff to support the Council; consider Mark Bozigian for the position of City Manager. Encouraged citizens to get involved - one person can make a difference; step forward, be involved, be that person.

Heather Brown – stated that her vehicle was taken by the City in 2007; requested help from the City in getting her property back.

Diana Beard-Williams – congratulated Mayor Parris and Council Member Marquez; she worked for Mayor Parris on his campaign; spoke to the character of Mayor Parris; money was spent to get his message out, not to do anything underhanded; Mayor Parris is very approachable; believes that Mayor Parris will work for the betterment of the community.

### **COUNCIL/AGENCY COMMENTS**

Mayor Parris stated some of the things that are coming in the future:

Law Day and a proposal of a task force initiative which will have a huge impact on pushing gangs back; different commissions such as a criminal justice commission. He requested that Vice Mayor Smith work with him and City staff to formalize this and requested that Council Member Marquez become involved as well.

Mayor Parris stated that he wanted to discuss the possibility of changing the Council meeting times and encouraged citizens to give their input on this.

Council Member Marquez proposed that the national motto be placed on the wall behind the City Council – something inspiring and requested that staff look into this.
