**Recommendation:**

**Background:**

Due to the growth within the Code Enforcement Division in the Housing and Neighborhood Revitalization Department, we recommend establishing the above listed classification to improve service delivery within the Department and the City. The monthly salary range for this classification is \$6,038 - \$8,105. As a result, the Code Enforcement Aide classification is now abolished. Staff recommends that the City Council approve this action.
