RESOLUTION NO. 08-89

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, ORDERING THE VACATION OF ROAD RIGHT-OF-WAY, LOCATED AT WEST AVENUE L AND THE WEST AVENUE L SOUTH RAMP.

WHEREAS, the existing road right-of-way is no longer needed and the vacation is required to develop the site.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The Resolution of Intention in the matter of vacation of the above described easement in the City of Lancaster was adopted by the City Council of the City of Lancaster on September 23, 2008, which resolution established the time and place for the public hearing on said easement vacation.

Section 2. Due notice of said hearing has been published and posted as required by law.

Section 3. All protests in this matter have been duly considered.

Section 4. That the City Council finds, from all the evidence submitted, that an easement as described in its Resolution of Intention, Resolution No. 08-81, is unnecessary for present or prospective road right-of-way purposes.

Section 5. The City Council does hereby order the vacation of that certain road right of way to the owner of record, described as follows (see "Exhibit A"):

A PORTION OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 34, TOWNSHIP 7 NORTH, RANGE 12 WEST, S.B.B.M. IN THE COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF THE PROPERTY DESCRIBED IN GRANT DEED RECORDED FEBRUARY 26, 2004 AS INSTRUMENT #04-0446557, AS SHOWN ON RECORD OF SURVEY FILED IN BOOK 217, PAGE 27; THENCE ALONG THE NORTHERLY PROLONGATION OF THE EAST PROPERTY LINE NORTH 07°33'12" WEST 42.28 FEET; THENCE LEAVING SAID LINE NORTH 89°57'01" WEST 16.10 FEET; THENCE SOUTH 76°46'25" WEST 149.93 FEET; THENCE SOUTH 57°13'23" WEST 43.13 FEET; THENCE SOUTH 03°44'18" EAST 5.54 FEET TO THE NORTH LINE OF INSTRUMENT #04-0446557; THENCE EASTERLY ALONG SAID LINE NORTH 89°02'05" EAST 204.63 FEET TO THE POINT OF BEGINNING. AS SHOWN ON EXHIBIT "A".

SAID PROPERTY CONTAINS MORE OR LESS 6430 SQ FEET.


