RESOLUTION NO. 08-100

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, ESTABLISHING A FEE WAIVER FOR QUALIFIED HOME BASED BUSINESS LICENSES ISSUED UNDER THE CITY'S BUSINESS LICENSE ORDINANCE

WHEREAS, the City Council of the City of Lancaster, California, has adopted Ordinance No. 847 amending Chapter 5.04 of the Lancaster Municipal Code relating to Business Licenses; and

WHEREAS, each applicant is required to pay an annual fee and either an application processing fee or a renewal processing fee unless exempt by Ordinance; and

WHEREAS, Section 5.04.060 of said Ordinance requires the City Council to establish the amount of the fee which shall cover the costs of processing and issuing licenses and enforcing said Ordinance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER AS FOLLOWS:

SECTION 1. Upon renewal of a business license, the Basic License Fee as set forth in Section 1 of Resolution No. 05-174, as may be amended from time to time, may be waived for any home based business (as defined in Section 17.04.240 of the Lancaster Municipal Code) earning less than Three Thousand Dollars (\$3,000.00) of gross revenue in the year preceding the renewal. In order to obtain the waiver permitted under this Section, a home based business must submit a copy of its federal income tax return and execute a declaration under penalty of perjury (on a form provided by the City of Lancaster) evidencing that the business earned less than Three Thousand Dollars (\$3,000.00) of gross revenue in the year preceding the renewal. Under no circumstances shall the Renewal Processing Fee set forth in Section 1 of Resolution No. 05-174, as may be amended from time to time, be waived.

SECTION 2. The waiver contained in this Resolution shall apply to all renewals processed on or after December 1, 2008.
