

RESOLUTION NO. 09-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, RESCINDING RESOLUTION NO. 07-108 IN ITS ENTIRETY AND ESTABLISHING THE PARKING PENALTY SCHEDULE

WHEREAS, civil penalties for parking and related violations are authorized by the California Vehicle Code and the Parking Citation Processing Ordinance No. 643, codified in Chapter 10.16 of the Lancaster Municipal Code; and

WHEREAS, with the passing of SB1407, the Courthouse Construction surcharge imposed by Government Code Section 76100 has increased \$3.00, from \$1.50 to \$4.50, resulting in the total amount per paid parking citation due to the state under GC 76000, 76100 and 76101 to increase from \$5.00 to \$8.00; and

WHEREAS, the City Council has determined that it is necessary to revise the Lancaster Parking Penalty Schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER AS FOLLOWS:

Section 1. Resolution No. 07-108 is hereby rescinded in its entirety and the parking penalty schedule, attached as "Exhibit A," is hereby established as the Lancaster Parking Penalty Schedule.

Section 2. This resolution shall become effective immediately upon its adoption.

**C. Late Payment Penalty**

Late payment penalty and administrative fees as set forth in Subsections A and B shall attach to the Base Penalty if the Base Penalty is not paid within twenty-one (21) days of issuance of the Notice of Parking Violation.

**D. Total Penalty**

The total parking penalty includes the Base Penalty, other special penalties and charges as provided in the California Government Code, California Penal Code, and California Vehicle Code; any Late Payment Penalty; and all Administrative Fees, assessments and costs of collection as provided by law pursuant to the California Vehicle Code Section 40200.3(f); whether or not itemized in Subsections A and B.
