## **RESOLUTION NO. 09-59**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, REQUESTING THE LOCAL AGENCY FORMATION COMMISSION TO INITIATE PROCEEDINGS FOR THE REORGANIZATION OF TERRITORY, DESIGNATED AS "ANNEXATION 2009-06," INVOLVING ANNEXATION OF 7,190 ACRES OF LAND TO THE CITY OF LANCASTER

WHEREAS, the City of Lancaster (the City) desires to initiate proceedings pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, commencing with Section 56000 of the California Government Code, for a reorganization that would annex territory to the City; and

WHEREAS, pursuant to the provisions of the California Environmental Quality Act (CEQA), the Mitigated Negative Declaration prepared for this project was approved with the Resolution for General Plan Amendment No. 09-01 and Pre-zoning No. 09-01 and the City Council reviewed and considered information contained in the Mitigated Negative Declaration prior to approving this project; and

WHEREAS, on June 23, 2009, the City Council conducted a duly noticed public meeting on the proposed request to initiate proceedings for the proposed annexation of territory to the City; and

WHEREAS, the principal reasons for the proposed reorganization are: 1) inclusion of the recycled water service area along the City's existing Division Street pipeline; 2) elimination of multiple jurisdictions for storm water management and facilitation of planning, design and construction of future improvements; 3) enhancement of current and future commercial and industrial development along Division Street employing green technologies, to be known as the "Lancaster Green Corridor;" 4) sustaining current service levels for facilities, fire, police and schools; and, 5) improvement of community connection to local government; and

WHEREAS, the following agencies would be affected by the proposed jurisdictional changes:

SECTION 1. The foregoing Recitals are true and correct.

SECTION 2. The Local Agency Formation Commission of Los Angeles County is hereby requested to initiate proceedings for the annexation of territory as authorized and in the manner prescribed by the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.
