

RESOLUTION NO. 09-88

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DIRECTING AND AUTHORIZING THE STREET NAME CHANGE OF COUNTRYWIDE WAY, LOCATED IN THE LANCASTER BUSINESS PARK AND SHOWN ON PARCEL MAP NO. 26467, TO HOLSTON DRIVE

WHEREAS, the City of Lancaster (hereinafter referred to as the "City") is a municipal corporation duly organized and existing pursuant to and under the provisions of the laws of the State of California; and

WHEREAS, the City Council, by its statute authority, has previously approved the street name for Countrywide Way; and

WHEREAS, said street name is now determined to be in conflict with the public interests and welfare; and

WHEREAS, the change of such street name is warranted.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The City Council hereby finds and determines that the public interest and necessity require the name of the affected street be changed from Countrywide Way, as shown on Parcel Map No. 26467, Map Book 304, Pages 69 and 70, to Holston Drive.

Section 2. The Public Works Department is hereby directed to change existing approved street name signs as affected by this resolution, which is required by the public interest and a necessity for the use and purposes set forth in Section 1.

Section 3. The City Council finds and determines that there is urgency required in making this change and therefore adopts this resolution to take effect immediately.

Section 4. The City Clerk is hereby ordered to cause a certified copy of this resolution, attested to by the City Clerk under the seal of the City, to be recorded in the Office of the County Recorder of Los Angeles County and to the Los Angeles County Board of Supervisors.
